Reference is made to the announcements of the Company dated 27 December 2018, 31 December 2018 and 11 January 2019 in relation to the alterations of the terms and conditions of the convertible bonds (the “Announcements”). Capitalised terms used in this monthly return shall have the same meanings as those defined in the Announcements unless otherwise stated. The Company repaid to the Purchaser a partial principal amount of the Convertible Bonds of HK\$10,000,000 and the Purchaser waived the Purchaser’s right of conversion on the Convertible Bonds in the principal amount of HK\$60,000,000. Upon the completion of the above, Convertible Bonds were then adjusted to an aggregate outstanding principal amount of HK\$84,000,000 with 77,064,200 Conversion Shares which may be allotted and issued upon the exercise of the Conversion Rights in full at the Adjusted Conversion Price of HK\$1.09 per Share.
